paid to it by Thomas Rosborough of Remuera
near Auckland retired farmer (the receipt of
which sum is hereby acknowledged) doth hereby
transfer unto the said Thomas Rosborough all
its estate and interest in the said land above
described Provided always and the said Thomas
Rosborough doth hereby for himself and his
executors administrators and assigns covenant
with the said Bank that the said Bank shall
not be liable to fence nor to contribute towards
the costs of the erection or maintenance of any
dividing or boundary fence between the land
hereby transferred and any adjoining land
belonging to it but this proviso and covenant
shall not be deemed or construed to encure
to the benefit of any purchaser or purchasers

of such adjoining land In witness whereof

this sixth day of March 1908


